CAP provides intake services as well as educational outreach to the disabilities community. Litigation represents individuals and classes in non-criminal matters to establish legal principles, benefit people with disabilities, and raise public awareness of the disability rights at issue and the Organization's commitment to the enforcement of those rights

CAP provided individual assistance in the form of brief services, referrals, and information to 350 clients in 2015. CAP intakes and community presentations and seminars are assisted by law-student interns throughout the year. CAP provides training and supervision to

The Cancer Legal Resource Center (CLRC) provides free confidential information and resources on cancer-related legal issues to people coping with cancer, caregivers, employers, health care professionals, and others. CLRC assists cancer patients to resolve legal issues related to insurance, access to quality care, government benefits, advance planning, financial management, and employment. CLRC also administered the HIV Law and Policy Program in 2015. This project worked to reduce the impact of HIV on vulnerable and marginalized communities, and to secure the civil rights of people affected by HIV.

End of Life Liberty Program (ELLP) works to empower mentally competent dying patients with the privacy and liberty to make autonomous decisions about their own body. ELLP focuses on reducing state statutory and constitutional barriers that prevent dying patients from making those autonomous decisions. The program attorneys collaborate with pro-bono counsel in selected states to represent patient and physician plaintiffs in lawsuits aimed at bringing about change to existing legal barriers. The ELLP cases are of significant societal interest, garnering headlines and prominent news commentary. This in turn fuels the public awareness and discourse about matters that affect everyone. The program also contributes to the meaningful public dialogue through presentations, publications, media appearances, and
